- **Daniel 9:27** introduces the final "week": "And he shall confirm the covenant with many for one week: and in the midst of the week he shall cause the sacrifice and the oblation to cease, and for the overspreading of abominations he shall make it desolate, even until the consummation, and that determined shall be poured upon the desolate." Here, a figure (often interpreted as the Antichrist in Christian eschatology) establishes a "covenant with many" for one week (seven years). However, halfway through this period,

he breaks this covenant, leading to abominations and desolations.

The "covenant with many" holds deep implications. In many eschatological interpretations, especially within Dispensational Premillennialism, this covenant is seen as a future peace treaty between the Antichrist and Israel.
